





Dear Mr. Mabuza,

I am writing to formally lodge a complaint and request an urgent correction regarding the most recent municipal account issued to me for the property located at 05 Kraalkop Street, Fochville.

The account I received, which covers the billing period **1 August 2025 to 31 August 2025**, contains an error in the meter readings. According to my records, I submitted both the electricity and water meter readings on the same platform, taken from **4 July 2025 to 4 August 2025**. These readings correlate exactly with what is reflected for **electricity usage** on the account, but it is readings that the accounts department used to calculate the usage for 1 August to 31 August 2025. Thus, it seems as

though 4 July 2025's reading has been used to calculate the usage for 1 August 2025 to 31 August 2025

However, the **water meter readings** appear to have been managed even more incorrectly. The starting reading used for August is the **ending reading from 4 August 2025**, and without any supporting consumption data for the remainder of August, an arbitrary usage of **25 kilolitres** has been allocated and billed. This creates an inconsistency, especially given that both electricity and water readings were submitted together for the same time.

I find this discrepancy concerning and unreasonable, as it suggests that the same data submitted was interpreted differently within a single billing cycle. It is unclear how a usage amount of 25kl was calculated when the readings do not support that.



Thank you for your attention to this matter. I trust that it can be resolved promptly and accurately.


